III. Chair's report, Vivienne Bennett: • Bennett asked EC members to advise her of their availability to meet with the four vice provost candidates who are visiting campus next week. • There will be an open forum and a faculty forum for Chancellor White's visit tomorrow. • A task force will be convened next week to work on the Academic Freedom policy; members are Ranjeeta Basu for APC, Arturo Ocampo, Michelle Hunt, and Mayra Besosa for CFA. • A list of referrals was printed on the agenda.

IV. Provost's report, Graham Oberem • The four semi-finalists for the vice provost position are all strong candidates in their own ways, and feedback will be greatly appreciated. • A best course of action for the CEHHS dean search has not yet been decided, though conversations have been started. The search for a Library dean will be underway shortly; an announcement will go into *The Chronicle* in early December and application review will begin in mid-January. Another search to be started around that same time is that for the AVP-Research/Dean of Graduate Studies position. A consulting firm is not being engaged for these searches. • The periodic review committee has now been seated for Dean Kantardjieff. Faculty members will be Jose Mendoza, Bill Kristan, Michael Schmidt, and Youwen Ouyang. Additional members are Laurie Schmelzer (staff) and Alex Azverov (student). • In response to a question, Oberem indicated that the vice provost will not initially have responsibility for WPAF reviews, though there exists the possibility of at least partial delegation of this responsibility in future.

B. LATAC CALM resolution Price introduced this item which expresses support for the Cougars Affordable Learning Materials (CALM), part of the CSU's Affordable Learning Solutions initiative.
