- **Chair's report, Vivienne Bennett:** Senate elections completed results were sent yesterday. #### VI. Discussion items

### A. NEAC Constitutional Amendments: APC, LATAC & PAC

**APC** proposed amendment to the committee's charge.

**LATAC** amendment - discussed at EC Meeting on 4/16/14.

**PAC** amendment - discussed at EC Meeting on 4/16/14 about adding a faculty member affiliated with an Interdisciplinary program. Also noted that footnote was missing on copy in agenda packet

Amendments will be sent as referendum to all faculty next week. Bennett reminded Swan that if the APC and PAC amendments are approved, new committee members will have to be seated.

## B. FAC University RTP Policy

Nava reviewed FAC's rationale for developing an exemption clause for the RTP document. The proposed exemption would allow a "four year postponement," for existing faculty members to adopt new RTP standards. All new TT faculty hires would fall under new policy. FAC developed an "Exemption Request" form which would be placed in the WPAF. EC made strong recommendation to change exemption. Nava restated that the CEHHS and SOE already have existing and functioning exemption clauses in their RTP documents and the CEHHS policy was used as a model for the university policy. Nava also mentioned Michelle Hunt had taken brief survey with her CSU colleagues and determined there is no good model for applicability of department RTP standards within university wide RTP policy. # C. FAC CEHHS, Speech Language Pathology RTP Standards

FAC has reviewed the SLP documents thoroughly and found them to be consistent with the university RTP document. Improvements were made to formatting in order to make it more clear to university-level reviewers. A unique aspect to the SLP document is a system of menus and lists to outline achievement and research.

#### D. BLP/UCC Pre-Health Professions Certificate

Post-Baccalaureate certificate for non-science majors. 51 units (mostly lower-division), no new curriculum – will use existing curriculum, cohort model. Classes will be offered mostly in evenings and weekends. Lecturers to be hired by EL and will not earn entitlements. Price is \$450 unit. Feedback has included concerns about attrition due to classes with lower pass rates. Modeled after other CSU Pre-Health Certificates which are very popular and many of them have waiting lists.

Broader concerns voiced around the inconsistencies in treatment of lecturers (hiring lecturers in EL who don't earn entitlements and other EL programs that hire lecturers through the college and earn entitlements). Senate Officers will schedule meeting ASAP with EL Dean to discuss.

#### E. NEAC/FAC Lecturer Inclusion, 2 options

1<sup>st</sup> option - broadens language to include Part-time lecturers with 1-year appointments.

2<sup>nd</sup> option – reserving 4 additional "at-large" Senate seats for part-time faculty. This would bring the total AS seats for part-time lecturers to 5. Concern was expressed over physical limits of the meeting room and whether there would be enough chairs. Some EC members pointed out that in most Senate meetings, there are several senators who do not show up, so there are those chairs. Bennett requested a straw poll which showed that a

majority of EC members recommended adopting option #2 to increase the seats for Lecturers on Senate by 4 (see vote outcome below). EC will vote on this on 4/30/14.
