VI. President's Report, Terry Allison:

The President's Office reported that the Panetta Institute Congressional Internship program is currently searching for a student intern from CSUSM. Advertisement for the position of Provost and Vice President for Academic Affairs was distributed and presented an informational item that will be distributed November 10^{th} – 17^{th} . Allison also shared a letter from the Chancellor's Office responding to CFA Director Jim Semelroth's letter dated October 9, 2000 regarding workload and collective bargaining issues.

VIII. Associated Student Inc., Humberto Garcia Jr.:

CSUSM ASI is sponsoring a college bowl on Saturday, November 4th. Associated Students Inc.'s Early Learning Center, taking part in the 2nd Annual Child Trot at Mangrum Track and Field on Saturday, October 21st and raised \$1,400. ASI encourages departments on campus to get involved in the 2nd Annual Holiday Basket Drive November 16th.

XI. Statewide Senate Report: Sandy Parsons

Strongly encourages EC members to keep the October 18th EC agenda due to the importance of the attached documentation on the CSU Master Plan.

X. CFA Report, Keith Trujillo:

CFA reported that based on the CFA forum last week it was concluded that CFA would look into creative ways to account for workload responsibilities and FTES. Overall, the forum was very positive.

XI. Committee Reports: APP, BLP, FAC, and NEAC

APP: Distributed a handout discussing Title 5 on the Committee of Educational Policy. Currently most Baccalaureate degree programs consist of 124 units. Degree programs that exceed 120 units (with exception of several degree programs) will have to justify the increase in units. Presented a resolution on class scheduling, EC did not move on the resolution. Currently classes at CSUSM run in blocks of 75 minutes. Not all classes are utilizing the 75-minute block time. APP and Academic Programs are seeking ways to utilize time allocated to classes. Scheduling block time to 50 minutes classes rather than 75 minute classes. Curriculum tracking proposal brought forth by APP.

Curriculum Tracking 2000/01 added to the Senate agenda 11/1/00

BLP: A one time \$5 million award from the Chancellor's Office was given to CSU campuses. CSUSM will receive approximately \$77,000. BLP suggested that the TULIP program receive the \$15,000. Faculty Center to receive \$15,000 to be utilized for faculty travel, professional development, and workshops. Colleges/Departments receive \$47,000 based on their FTEF. Also encourages colleges to consider allocating funds to their part-time faculty.

Motion #4 M/S/P (Roark/Stowell) To endorse the preceding proposal by BLP

FAC: Report Attached. FAC brought forward a resolution to create a task force to address issues surrounding workload.

EC form a task force with representation from APP, GEC, BLP, FAC, CFA and other appropriate bodies to study and make recommendations regarding accounting for faculty professional responsibilities. Recommendations could consider issues such as the writing requirement, service learning, innovative curriculum, scholarship, creative activity, and service.
