- IV. Secretary's Report: Mohammad Oskoorouchi A written report was provided.
- V. President's Report: Karen Haynes Despite our challenges, we still look forward to the new year. The budget for the state is still not settled. Next week's budget forum will be to discuss any news as well as looking ahead. Much of this year will be a balancing act to deal with immediate needs while focusing on the future. In January we will begin celebrating our 20th year. This is the worse fiscal crisis any of us have likely seen, and it is not over. We will get through it, together, and it will be important for us to not only talk with one another but to communicate our disappointment in our legislature. We share the same goals and concerns, angers and frustrations.
- VI. Provost's Report: Emily Cutrer It is exciting to start the new year, and we have opportunities to made a real difference in our students' lives. Next Thursday will be the first of a series of Academic Affairs town halls. We received reaccreditation for seven years from WASC; much of the work ahead involves shared governance, including program review, student learning outcomes assessment, and aligning our academic planning with our budgeting. Our external funding for grants reached record highs last year. A proposal is pending for \$15M for a research center. Kudos to all for your hard work and dedication. Furlough update: Any request for an extension of probationary period that falls within the new guidelines will be granted. We will move forward with the sabbatical leave process and will expect to grant about the same number as last year (about 13). The RTP calendar is now posted. CoBA's Jim Hamerly will facilitate an upcoming town hall about going paperless. Planning for academic technology will be a focus this year.
