Written Committee Reports

BLP	In February, BLP members participated in a joint session with the Academic Affairs Leadership Group (AALC) to discuss AA priorities for budget cut recommendations that will go to the University Budget Committee in March. BLP is writing a policy on Academic Affairs Structuring based on the report of the AA Structuring Task Force. We expect the policy to come to Senate in April. BLP appointed the Budget Reconciliation subcommittee to analyze methods of calculating SFR and reporting allocations to various categories of instructional/non-instructional funding, including trends and comparisons with other CSU campuses. The subcommittee is scheduled to provide preliminary reports to BLP at their March 10 and March 17 meetings. BLP is reviewing the P-form for the proposed program of the Bachelor of Arts in Environmental Studies.
GEC	GEC hopes to organize a series of lunches during March-April for faculty interested in providing feedback on the drafts of the General Education Learning Outcomes. There are drafts for Oral Communication, Area B, C, and D. We are currently looking over a draft GE handbook.
NEAC	NEAC is completing a thorough review of the election rules for an upcoming referendum. NEAC continues to make progress in ensuring that Senate committees are fully staffed and faculty are represented.
SAC	During the Fall 2009 semester, SAC worked on two absences policies: the Student Athlete Absence Policy and the Student Absence from Class for University Events and Religious Observances. The first policy (Student Athlete) was approved by Senate in its December meeting. The second policy (religious observance absences) had a first reading at Senate on January 3, 2010. SAC is currently working closely with the Dean of students, Dr. Bridget Blanshan on the university Student Grievance Policy . SAC will be presenting the Grievance Policy as a hand-out to EC on February 24m 2010. SAC's next task will be to work on the CoE Grievance Policy .
