- III. Chair's Report, Wayne Aitken Aitken noted the list of referrals attached to the agenda. There will be a forum regarding CSU Online on November 30 from 1:30-3pm; President Haynes, who serves on the governing board for CSU Online, will discuss and respond to questions. The General Education Committee is revising the GE handbook, which will be presented to the Senate in parts for feedback.
- IV. President's Report, Karen Haynes Unable to attend.
- ٧. Provost's Report, Emily Cutrer The external reviewers were very complimentary about our Biology program. We also had a great review with the Board of Registered Nurses. Cutrer provided a handout illustrating graduation rate goals and achievements. We have now exceeded our Graduation Initiative Steering Committee goal for 2015 of 45%. Our 6-year rate has gone from 35% to 47.3%. We continue to close the "success gap"

between underrepresented minorities and other students; in some cases, the underrepresented minority student rate exceeds the other student rate. Our one-year continuation rate for students admitted in fall of 2010 represents an all-time high of 79.6%, up from 77.3%; underrepresented minorities are at 79.2% and non-underrepresented are at 79.9%. Key to these efforts have been David Barsky, Eloise Stiglitz, and Catherine Cucinella. Mike Schroder reported that Extended Learning will be arranging bus trips for faculty to tour the Temecula facility and possibly other key points in the region. Trips are tentatively planned for December and February.

- VI. VP for Student Affairs Report, Eloise Stiglitz Enrollment is now closed for spring admissions except for veterans, active duty military, international students, and the Integrated Credential program. Fall enrollment is open through November 30 for full-time freshmen and transfers. Priority registration for spring will begin on November 17. Jeff Harlig has been hired as our new Senior Associate Director for CLAS and Director of the Writing Center. Civility Day is celebrated the first Tuesday of each month; green Civility t-shirts are available from Greg Toya in Student Affairs. Common Read events include a November 15 showing of *Gattaca*, and on November 16 speaker Chris Frost (SDSU) will present *Mortal Life*, *Immortal Life*: On Loss, Grieving, and Melancholy. Also on November 16, our campus will co-sponsor Homeless Connect, a one-day program to connect community members in need with services and resources.
- **VII. ASCSU Report** The ASCSU will hold a plenary session on November 3-4. Meilich asked for feedback on the ASCSU proposed resolution calling for the Trustees to develop a formal policy on presidential compensation; Barrett stated that it was inappropriate to consider presidential salary increases when inflation-adjusted faculty salaries have fallen; a number of senators concurred with this sentiment.
- **VIII. CFA report, Don Barrett** Barrett noted that increased graduation rates are dependent upon good morale in the faculty workforce; good morale is dependent upon respect, reasonable workload, and fair compensation. Planned actions for November include informational picketing on November 9 and (tentatively) travel to Dominguez Hills on November 17 to show support for striking CSUDH faculty.

- X. Oral Committee Reports Written reports were provided by all committees.

FAC: Santamaría described the committee's current work, including consideration of a paperless Working Personnel Action File (WPAF).

PAC: Shaw explained PAC's role as a resource to external reviewers and its responsibility to respond to program reviews.

UCC: Breuer noted that UCC is considering modifications to the C and P forms in response to changes in course and program instruction sites and modes of delivery. She also described multiple serious concerns about the Early Start mandate which have been expressed to and within UCC, and are described in the documentation included in UCC's report to Senate.

BLP A Form revision** Beavers presented this form modification intended to reflect the development of programs offered via self-support, off-site, and online options, and to capture specific information about sources of funding, modes of delivery, and accreditation requirements. - C. SAC Faculty Management of Student Course Records policy revision Meilich introduced this item, noting that the committee received guidance from Teresa Macklin, IITS, regarding security issues. Senators suggested that SAC address the variety of circumstances which call for security and suggest ways to comply with the spirit of FERPA. Comments to Meilich.

XV. Information Items

- **A. Standing Rules revision** Aitken noted that the Standing Rules of the Academic Senate were modified by the Executive Committee (EC) to clarify the description of the Consent Calendar (item 2) and add language requiring Senate approval of substantive changes to committee forms (item 9).
- **B.** APC Graduate Probation, Disqualification, and Reinstatement policy revision Aitken noted that APC reviewed the policy in light of the restructuring of Academic Affairs and found that an editorial change is deemed necessary in the last line of the policy: "Reinstatement for credential students is handled by a separate process in the College School of Education and is not governed by this document." Such a change may be made without the need for Senate review or approval.
