- Chair's report, Jackie Trischman: Trischman acknowledged Don Barrett's retirement, noting this would be his last EC meeting. A. Student Course Grade Appeals policy revision Meulemans explained that the policy was reviewed by the administration following its approval by the Senate last spring. It was returned with a suggestion to consider requiring some minimum qualifications for the undergraduate student members of the Appeals committee. Following discussions with ASI and staff, SAC proposes the requirement that undergraduate students have at least junior status and a minimum of 30 units completed at CSUSM.
