III. Chair's Report: Gilbert Valadez

A. Announcements: Marcia Woolf has been named an Employee of the Month for May. Valadez welcomed the new senators for 2007/08.

V. **President's Report: Karen Haynes** Haynes thanked the senators for their role in keeping focused on student learning despite the contract difficulties. It has been a positive year: we have experience unprecedented growth, and growth in our students of color. Passage of Proposition 1D means continued progress on facilities planning. We are the only CSU with memorandums of understanding with two school districts – San Marcos and Escondido – as well as with a tribe – the Santa Ysabel tribe. Tomorrow we will sign an MOU with San Pasqual Academy, a facility for foster youth, believed to be another first in the system. Haynes also commended the BLP and UBC for expanding what appears to be a more inclusive and specific budget process. This year also saw the appointment of an interim diversity officer, as well as the appointment of Haynes as the chair of the system's Commission on the Extended University and as one of four presidents on the system's Task Force on Accountability. The outcome of Haynes' third-year performance evaluation will be made public by the Chancellor's Office shortly.

VI. **Provost's Report: Emily Cutrer** Cutrer thanked the senators for an exciting first year and congratulated the campus on all of its accomplishments. A task force has been formed to look at the methodology for considering salary equity requests; Holt is chairing. A systemwide Access to Excellence summit was held last week in Newport Beach; major issues included community relations, faculty roles, and the pipeline to the university. We are expecting 7,250 FTE students in fall, and are considered one of five "hot" campuses in the system. We continue to be congratulated for the widespread involvement and engagement in our recent WASC visit. In March 2009 we will have an "educational effectiveness" WASC visit; planning for this visit will be addressed this fall.

VII. ASCSU Report: Montanari The ASCSU's recent Legislative Days appear to have been very successful. The final plenary session will be held next week.

VIII. CFA Report: Janet Powell The contract ratification voting is currently underway. Local officers for next year have been elected: Janet Powell, President; Lance Newman, Vice President; Staci Beavers, Secretary; Andre Kundgen, Treasurer; Mayra Besosa, Lecturer Representative; Sharon Elise, Affirmative Action Officer; David Avalos, Faculty Rights Representative. CFA is working with Stivers and the Senate to prepare for an alternative grievance system which involves an elected faculty panel. CFA Lobby Days will be held next week.

IX. ASI Report: Jeremy Mills Mills thanked the faculty and administration for their support his year. ASI continues to lobby for a buy-out of the 10% fee increases, restoring of the outreach funding, the student services initiative that the Trustees have requested over and above the compact agreement, and support of AB 302. The California Higher Education Student Summit was held a couple of weeks ago in Sacramento and was a huge success. Caitlin Gelrud is the new ASI President, and Felipe Robinson Zañartu is the new Vice President for External Affairs and will represent ASI on the Academic Senate next year.

X. Year-End Committee Reports Written year-end reports were provided for all committees. Whittlesey noted that GEC will be reviewing Area E (Life-Long Learning) next year, and encourages curriculum development in this area. He also noted that, currently, our GE program is 51 units compared to the state required 48, and the Chancellor has requested a reduction to 45. He added that the size of our GE program sometimes poses a problem for programs trying to reduce their units to completion, and may merit reconsideration. Hayden noted (1) a typographical correction to FAC's year-end report, (2) that FAC will be considering the student evaluation process next year and welcomes feedback, and (3) results of the lottery grant process will be available in the next few weeks.

Stivers indicated that she has researched the issue of using the term "school" and found no official policies, but rather a nationwide culture exists for using that term in the field of Nursing.

E. APC Academic Calendar: 08/09 and Beyond Oskoorouchi indicated that the campus may opt to celebrate Cesar Chavez during the week following spring break. Several corrections were noted: (1) on the assumptions page, the third bulleted item should read: "Summer session runs for 11 weeks. In the 11-week Summer, the sixth week would be cut in half (different cuts depending on which day Independence Day falls on). The first day of instruction is sometimes a Saturday if the first half-session would otherwise have two fewer Saturdays than the second half-session; this is an 'Independence Day effect;'" (2) the heading on page 17 should read "Fall 2010" rather than 2011; and (3) several application filing period notes required correction. Comments included: (1) concern about lack of down time for faculty who are required to teach in programs with required summer courses; and (2) eleven rather than ten weeks for summer ensure higher quality courses.
