- become familiar with current approaches to the teaching of reading and writing in culturally and linguistically diverse elementary school classrooms.
- become familiar with classroom diagnostic techniques and evaluation procedures.
- become familiar with current approaches to the teaching of reading and writing to children with special learning needs.

ASSIGNMENTS

Reading Reflections (10 points): It is expected that everyone will have an understanding of all the readings and will come to class prepared to discuss them. Write at least 3 comments or questions from the readings for that session. Do not summarize. Please give thoughtful reactions, responses, and reflections. If the readings are from more than one book, try to comment on more than one book. We will use these as the basis of our discussion at the beginning of some classes. I will collect them at the beginning of each session and they should show that you have done the reading. You do not have to write comment cards for the children's literature readings. If a reading is repeated, do not comment on it again. Due each class session beginning with the 2nd session with 3 free passes!

Writing Strategy Lesson Plan (Critical Assessment Task) (10 points)

You will write and present a writing **strategy** lesson plan for a small group or whole class activity that takes into account the needs of your students. They can be mini-lessons, direct instruction, inquiry, or any format you choose. This is also an opportunity to try a writing-in-the-content-areas lesson. Make your lesson active, interesting, fun and meaningful. See the *Craft Lesson's* books and the standards for ideas. Examples of possible strategies include:

- How to begin a piece of writing
- Writing an engaging opening
- Narrowing or expanding topics
- Using a piece of literature as a model for writing
- Writing paragraphs
- Developing characters
- Organizational structure for a particular kind of writing (compare/contrast, persuasion, etc.)
- Monitoring your writing to see if it makes sense
- Editing your writing

- Comma usage
- Making transitions between paragraphs
- Using graphic organizers to write
- Using active verbs
- Peer response

Keep in mind when writing your lesson: What is the purpose of your lesson? How does it relate to real writing? What are your learning goals? How are they aligned with the CA Reading/Language Arts standards (check the Reading/Language Arts framework for CA public schools)? How will you present the lesson (instructional strategies, resource materials, time frame)? How will you group students for the lesson? How will you assess your students? What accommodations will you provide for students who need additional help?

Important: Your lesson must address the needs of mainstream students, as well as make provisions for second language learners, students presenting difficulty, and accelerated students. How are you going to work with students who are having difficulty? How will you scaffold English learners' learning during the lesson? How will your lesson provide enrichment for accelerated students? Will you meet with students individually or in a small group while other students work independently?

Bring enough copies for the cohort on the day you demonstrate your lesson. Due Feb. 24

Writer's Notebook (10 points)

For the purposes of this assignment you will keep a writer's notebook which you will use in class to explore different types of writing. In this notebook you will write first drafts which may be shared in peer conferences. At the end of the course, you will be asked to reflect upon and write about your own writing process. How did you get started? What was it like writing the first draft? What was difficult for you? What was easy? What kinds of decisions did you have to make in the writing? Did you consider an audience when you were writing? Who was your audience? Especially respond to: What did you learn about fostering student's writing through this experience? DO NOT BEGIN THIS ASSIGNMENT UNTIL IT IS DISCUSSED IN CLASS! The notebook and reflection are due March 14.

Case Study (Critical Assessment Task (40 points)

Choose a student at your school site who struggles with reading and writing (the teachers will help identify students). Choose a student who is reading at least at a first grade level. Don't shy away from English language learners. Ask your master teacher for a good candidate and discuss with them possible times for giving the assessments. Prepare a reading and writing case study on this student.

<u>Important:</u> Take notes as you work with your student. Include your anecdotal notes in the final appendix. (for example, your student's behavior during the activity, reactions to the activity, comments, etc.) in your analysis of the student and in your design of an appropriate instructional plan. **Record all the student's oral responses on tape. Don't try to assess the child in only one day.** If you think the child is getting tired, stop the assessment for the day and pick up another day. An important part of the assessment is developing a rapport with the child in which s/he is comfortable to fully participate.

Assessment Procedures with Grades 3-6:

- 1. <u>Overview:</u> Age, grade level, interests, ethnic and linguistic background, etc., based upon your observation of the student and information obtained from the classroom teacher. Select 3 students just in case students move or change schools and you need a backup, however you are only going to be working with one student.
- Reading interview: Use an attitude survey (included with in the Case Study packet).
 Summarize the interview and include the original responses in an appendix.
- 3. Word list: Use the graded word lists to ascertain the level at which you will have your student begin to read the reading passage. Start at 2 to 3 grade levels below your student's grade level placement. Use Johns (form A).
- 4. <u>Text reading level</u>: Use your student's graded word list score to ascertain the level at which you will have your student begin to read.

- 5. <u>Oral Reading</u>: Use Johns narrative (form A) passage and Johns instructor forms to take a running record. Remember to record the student's reading.
- 6. <u>Miscue Analysis</u>: Listen to the tape and analyze the miscues made by your student. Use the miscue analysis handout (handed out in class) or Johns (p. 142) to help in your analysis. What cueing systems did your student use to make meaning? What are the strengths of your student? Use the analysis sheets in the Johns and transfer that information to the assessment grid provided in the Case Study packet to record data about your student. Write your analysis in a clear manner. As you write your analysis, consider your original reading interview and observations and consider how the answers given by the student during the interview connect to the miscues. Also consider the quality of the retelling and how you think that is related to the
- 7. Retelling and Reading Comprehension: Before your student reads the passage, be sure to tell him/her that you will be asking him/her to retell the story/passage. Ask the comprehension questions as listed in the Johns IRI. Also use the criteria provided in the Johns to analyze the student's retelling.
- 8. Oral Reading/Expository Passage: Repeat steps 4-7 using an expository passage.
- 9. Writing assessment: Obtain a writing sample from the student. Have him or her write about a favorite toy, book, food, sport or anything that is personal to this child or use a piece of writing that the teacher has on file. Personal writing encourages more writing. Students can draw if they want to. You will want to see what stage of writing the child is in as well as the child's ability to manipulate this abstract type of language. Based upon your analysis of your student's writing sample as well as the interview questions related to writing, summarize the student's strengths and areas of need and transfer that information to the assessment grid.
- 10. Recommendations: Based on the information you have gathered about the student, discuss his or her strengths (very important what can he or she already do) and weaknesses what does this student need to work on. Make **specific** instructional recommendations for how a teacher could work with this student in the future. You might also make recommendations for the student and parents: what can the student do on his or her own that is not dependent on the teacher.
- 11. <u>Instructional Plan:</u> Design an instructional plan for your student. You are the teacher. Knowing what you know about your student as a result of assessment, what areas would an appropriate instructional plan focus on? Why? Refer to the standards in the Reading/Language Arts Framework for CA Public Schools for your child's grade level to guide you as you design the intervention plan.
- 12. <u>Reflection:</u> What did you learn about assessment through this process? What did you learn about children's reading, writing and oral language development? What did you learn about developing an instructional plan and making instructional decisions based on assessment? What would you do differently or try differently? What other scaffolds or strategies would you use? How would you use them? What other interventions would you try? What would your next steps in assessment be?
- 13. <u>Appendix:</u> Be sure to include the reading and writing interviews, the Johns forms, writing samples, and any anecdotal notes in an appendix.

For your final write-up, be sure to follow the Final Project Outline on p. 2 of the Case Study packet.

Bring the data that you have to class **March 3** and we will troubleshoot and help analyze. **Final Case Study due March 10.**

Language Arts Resource Notebook (Part 2) 20 points

Each of you will develop a Reading/Language Arts Resource Notebook that will be used to inform your teaching. The Resource Notebook has two main objectives. The first objective is to demonstrate your learning and understanding of the reading and language arts. The second is to start building a resource for your own teaching. Be creative and thoughtful in the compilation of the notebook—it will be a demonstration that you are ready to teach the language arts to a diverse student population.

The Notebook will be organized around the 13 RICA Content Areas and include additional sections on:

- · A personal statement of your philosophy of the teaching reading and writing
- Writing
- RICA Study Terms

Each section of the notebook should contain the following:

- A RICA analysis sheet including: (a) what this content area(s) is about (put it in your own words –
 2 to 4 sentences), (b) 2 ways of assessing this content area (include rationale); and (c) 1 way of
 teaching it (description and accommodations). Describe the teaching strategy and explain how it
 supports reading, writing and/or language arts development. I will review this information as we
 cover the content for this course.
- An observation form
- A technology-rich assignment that enhances your teaching and student learning
- Lesson plans, articles, and any other resources collected within class or student teaching that would be helpful.

For the second semester you will need to complete the following content areas:

- Content area 1 Conducting Ongoing Assessment of Reading Development
- Content area 8 Literary Response and Analysis
- Content area 9 Content-Area Literacy
- Content area 10 Student Independent Reading
- Content area 11 Relationships Among Reading, Writing, and Oral Language

You can choose how to organize this information in your notebook. You may combine several of the content areas in ways that make sense for instruction. You may include course assignments (lesson plan. classroom observations and journal entries), course handouts and materials from your classroom/school site, examples of lesson plans and student work, information from Internet sources or professional journals. You may want to include strategies you will use to teach these content areas. You may even include pictures of students learning a specific strategy as well as your reflection on what was happening, why it worked or didn't work and why that was. You may include one (or more) successful activities that you used in the classroom (must be related language instruction). arts

Begin early! Be creative and thoughtful! This resource notebook will contain samples of your learning and understanding, and examples of your work that demonstrate that you are ready to instruct children in reading, writing, listening and speaking. Feel free to use a variety of graphic and written presentations, as best suits your learning style, in order to show your learning and understanding. Use a three-ring binder to organize your materials. Work with a friend so you can exchange ideas.

As you learn about assessment, content area literacy, the role of independent student reading, the relationships among reading, writing and oral language and other components crucial to effective literacy instruction, compiling your resource notebook will help you prepare and review the content areas assessed by the RICA test. More importantly, it will serve as a resource for you in the future, and may be used for job interviews to illustrate your knowledge and experiences. I will explain and review information as we cover the content for this course.
