## COURSE DESCRIPTION

Required for all credential candidates. An orientation to careers in K-12 education. Focuses on teaching and schooling from multiple perspectives, with an emphasis on current practices in public education in the U.S. Subjects from the sociological, philosophical, and historical foundations of education are addressed. Readings and interactions with local educators will promote an understanding of the richness and complexity of teaching as a career in a diverse society.

DUE TO COVID-19, in-person participation in fifteen (15) hours of fieldwork assignments in K-12 classroom settings will now take place via curated videos. Certificate of Clearance and Tuberculin (TB) Risk Assessment will therefore not be required – however, since these are required for entrance into the credential program, securing this documentation as soon as possible is highly recommended.

### Course Objectives

This course serves as an orientation to careers in elementary, middle and high school education. Upon completion of this course, teacher candidates should understand the nature of formalized education in the United States and be able to assess his or her interest in teaching as a career. By the end of the course the student will be able to develop an informed personal philosophy of teaching.

Major topics include:

- Understanding the roles of schools in society
- Understanding philosophies and contemporary issues in education.
- Understanding the roles of teachers in schools.
- Understanding the qualifications and credentialing process for California teachers.
- Understanding and appreciating the student as an individual.
- Understanding factors affecting student achievement.
- Understanding critical issues in curriculum and instruction.
- Understanding infusion of special education in general education practices.
- Understanding the laws that influence teaching responsibilities.

This course is a required pre-requisite for all applicants to CSUSM's K-12 credential programs.

### Unique Course Requirements

Teacher education is a professional preparation program. It is expected that students will come to class prepared to discuss the readings, submit required assignments, and participate in class activities. The School of Education has identified six dispositions – social justice and equity, collaboration, critical thinking, professional ethics, reflective teaching and learning, and life-long learning—Students are expected to adhere to academic honesty and integrity, standards of dependability, confidentiality and writing achievement. Because it is important for teachers to be able to effectively communicate their ideas to students, parents, colleagues, and administrators, writing that is original, clear and error-free is a priority for the School of Education.

*It is expected that work will be submitted on the due dates assigned. Please discuss individual issues with the instructor. Points will be deducted if assignments are submitted late (10% penalty per day late; no credit will be awarded if the assignment is one week late).*

### Fieldwork

In addition to in-class work, assigned readings, and projects -- students will watch and reflect on fifteen (15) hours of curated videos from a variety of school settings. Fieldwork details are found on the Cougar Course site. Documentation of these hours is required to receive a grade in EDUC 350.

**Expected Dispositions for the Education Profession**

Education is a profession that has, at its core, certain dispositional attributes that must be acquired and developed. Teaching and working with learners of all ages requires not only specific content knowledge and pedagogical skills, but positive attitudes about multiple dimensions of the profession. The School of Education has identified six dispositions that must be evident in teacher candidates: social justice and equity, collaboration, critical thinking, professional ethics, reflective teaching and learning, and life-long learning. These dispositions have observable actions that will be assessed throughout the preparation program. For each dispositional element, there are three levels of performance - *unacceptable*, *initial target*, and *advanced target*. The description and rubric for the three levels of performance offer measurable behaviors and examples.

The assessment is designed to provide candidates with ongoing feedback for their growth in professional dispositions and includes a self-assessment by the candidate. The dispositions and rubric are presented, explained and assessed in one or more designated courses in each program as well as in clinical practice. Based upon assessment feedback candidates will compose a reflection that becomes part of the candidate's Teaching Performance Expectation portfolio. Candidates are expected to meet the level of *initial target* during the program.

**Credential Program Recommendations**

As one of several evaluation methods, EDUC 350 course instructors are asked for feedback concerning credential candidates who are applying for programs at Cal State San Marcos. Keep in mind that your professionalism and hard work in this class not only affect your course grade, but also indicate your readiness for a credential program.

**Final Exam Statement**

There will be no final exam for this course.

**School of Education/Course Attendance Policy**

Due to the dynamic and interactive nature of courses in the School of Education, all students are expected to attend all class sessions and participate actively. Students are expected to demonstrate competency in the use of various forms of technology (i.e. word processing, electronic mail, Cougar Courses, use of the Internet, and/or multimedia presentations). Specific requirements for course assignments with regard to technology are at the discretion of the instructor. Keep a digital copy of all assignments for use in your teaching portfolio.

## **Electronic Communication Protocol**

## 1. Reading Response Journals

**(TPEs Introduced: 1.6, 2.3, 2.6, 3.1, 3.7, 4.1, 6.5, 6.6)**

Students will complete weekly readings. This assignment provides students with opportunities throughout the course to be introduced to knowledge related to a breadth of topics related to the foundations of teaching as a profession. The Reading Response Journal is a forum through which students can synthesize and reflect on many aspects of teaching, learning and schooling.

The following topics are introduced throughout the weekly readings in this course:

- Provide a supportive learning environment for students' first and/or second language acquisition by using research-based instructional approaches, including focused English Language Development, Specially Designed Academic Instruction in English (SDAIE), scaffolding across content areas, and structured English immersion. And demonstrate an understanding of the difference among students whose only instructional need is to acquire Standard English proficiency, students who may have an identified disability affecting their ability to acquire Standard English proficiency, and students who may have both a need to acquire Standard English proficiency and an identified disability. **(TPE 1.6)**
- Establish, maintain, and monitor inclusive learning environments that are physically, mentally, intellectually, and emotionally healthy and safe to enable all students to learn, and recognize and appropriately address instances of intolerance and harassment among students, such as bullying, racism, and sexism. **(TPE 2.3)**
- Establish and maintain clear expectations for positive classroom behavior and for student-to-student and student-to-teacher interactions by communicating classroom behavior and for student-to-student and student-to-teacher interactions by communicating classroom routines, procedures, and norms to students and families. **(TPE 2.6)**
- Demonstrate knowledge of subject matter, including the adopted California State Standards and curriculum frameworks. **(TPE 3.1)**
- Model and develop digital literacy by using technology to engage students and support their learning, and promote digital citizenship, including respecting copyright law, understanding fair use guidelines and the use of Creative Commons license, and maintaining Internet Security. **(TPE 3.7)**

- Demonstrate professional responsibility for all aspects of student learning and classroom management, including responsibility for the learning outcomes of all students, along with appropriate concerns and policies regarding the privacy, health, and safety of students and families. Beginning teachers conduct themselves with integrity and model ethical conduct for themselves and others. **(TPE 6.5)**
- Understand and enact professional roles and responsibilities as mandated reporters and comply with all laws concerning professional responsibilities, professional conduct, and moral fitness, including the responsible use of social media and other digital platforms and Preliminary Multiple and Single Subject Credential Program Standards – Adopted December 2015 14 Teaching Performance Expectations (TPEs) – Adopted June 2016 tools. **(TPE 6.6)**

Students will carefully review each week's readings and prepare a thoughtful written reflection response. The purpose of the reading journal is not to have students simply summarize the reading but instead for you to identify 5 or 6 key points/quotes from the chapter – and then reflect on how each point connects to your own educational experience or thinking about teaching by doing one of the following: *giving an example* of what the reading described; *providing a different perspective* of the topic in the reading; *connecting the reading to a personal experience*, and/or *expanding upon the idea* in the reading by including more detail and depth. This supports students' ongoing class discussions about the readings as well as their engagement in activities related to the readings. Students will submit the weekly readings journal as directed. The journal will be graded holistically; you will receive either full credit or none. A model will be provided. Journals must be typed. No credit will be given for late submissions.

## 2. Current Events in Education

On a designated date, you will present a current event from the week's news in K-12 education. The item must be from a reputable news source and may pertain to local, national, or international issues. Do not submit "news" from personal blogs, newsletters, or other opinion sources. You will summarize and present the importance of the news for your classmates in 5 minutes maximum. Be sure to make a connection to future teachers in California.

This assignment will be graded as either 0 or 5 points; there is no partial credit. To earn 5 points, you must: (1) present a different current event from previous presentations on the date you are assigned; (2) engage in discussions on current events presented by your group; and (3) email your instructor with the link to your article sometime during the week prior to your presentation.

## 3. Interview of a Teacher

### (TPE Introduced: 6.3)

In this assignment, students gain insights about the profession of teaching by analyzing the information gathered during an interview with a teacher. This assignment introduces students to the professional practice of communicating with and learning from teacher colleagues. Students are introduced to the importance of being able to: *Establish professional learning goals and make progress to improve their practice by routinely engaging in communication and inquiry with colleagues (TPE 6.3)*. Students are asked to render a sketch enabling readers to envision the teacher as a person with a distinct philosophy and experience.

Students interview a teacher (current or recently retired). Ideas for questions will be provided and students are also encouraged to design their own questions. Then, students write a 3 to 4 page analysis of what they learned in narrative form, analyzing the teacher's responses and making explicit connections to ED 350 course readings and activities. Students identify insights about teaching from the teacher's experience. In a personal reflection, they apply that to their own thinking about what it means to be a teacher and any implications for their own plans to pursue teaching as a career. More detailed guidelines are provided on Cougar Courses.

Exemplary papers are characterized by the following: 1) Clarity of description of the teacher's experiences and views, 2) Multiple, explicit connections of coursework (Sadker/Zittleman, class activities) in the analysis, 3) Explanation of how the teacher interview relates to the student's own thinking about teaching as a career, 4) Correct grammar, syntax, spelling.

## 4. The Outsider

Many students with special needs come to view themselves as "outsiders" because they are labeled as different from the typical student. However, most of us experienced some sense of being an outsider during our K-12 years. After considering course readings, students will write a reflective essay (2 to 3 pages, double-spaced) about one's own (or a friend's) school experience that elicited feelings of being an outsider. Reasons could include differences due to gender, religion, looks, beliefs/interests, family situation, economics, academic ability, etc. At least **one** specific connection (**quote**) to course readings is required.

Consider the following questions:

- What personal characteristics fostered your (or your friend's) feelings of being an outsider?
- How did you react to and cope with the situation?
- Did you share your experience with any teachers or other school personnel? Did any of them assist you?

- What could school staff, parents or friends have done to help?
- In what ways did this experience change you? Did you “learn” from this experience?
- How might this experience make you a more sensitive and effective teacher?

Exemplary papers are characterized by:

- Addressing the questions above in a thoughtful/analytical manner
- Integration of the assigned readings, including at least one quote
- Correct grammar, syntax, spelling

## 5. Contemporary Issues Research

Students will choose a major contemporary issue in education of interest, from a variety of topics provided – then research the issue, create a visual presentation using such technology as PowerPoint/Prezi, and give an oral report to teach the topic to class colleagues. The presentation should describe the issue, its pros and cons, analyze the issue’s implications (the “so what”), and provide a conclusion, in 10 minutes, leaving 5 minutes for Q & A.

For the presentation, students will submit the presentation slides (about 10-15) to the instructor, provide “homegroup” classmates with a one page typed narrative abstract summarizing the topic, and complete a reflections sheet to capture what was learned from others’ presentations. Additional guidelines, format, and suggested topics will be discussed in class and posted on Cougar Courses.

Key skills/knowledge for evaluation:

- Do you understand a major issue affecting education and can you speak intelligently to your peers?
- Did you read from enough sources to gather relevant information and then present this in a synthesized manner?
- Does your presentation include specific references to research on your topic?
- Does your presentation include the use of Power Point, Prezzi or similar technology?
- Did you present your information confidently, creatively, concisely and in an organized manner?
- Are you able to apply what you’ve learned about effective teaching to engage your audience during your presentation?
- Did you develop an informative handout (one page narrative abstract) and complete the reflections sheet?

## 6. Classroom Observation Reports (4)

This assignment is designed to help you better understand the complexity of today’s classrooms, students and the various ways teachers address the needs of their classes – and to engage in a variety of classroom settings in order to determine if, and at what level, you might want to teach.

Students will maintain a log of hours spent observing in classrooms. DUE TO COVID-19, OBSERVATIONS WILL TAKE PLACE USING CURATED VIDEOS PROVIDED BY THE INSTRUCTOR. This log must reflect a minimum of 15 hours spent in the various required classroom settings and grade levels as noted on the observation guidelines located on Cougar Courses. In addition, students will reflect on and analyze their field observations, make connections to concepts studied in EDUC 350, and identify lingering questions through 4 formal written Classroom Observation Reports. Check Cougar Courses for more information on fieldwork instructions. You must submit at least one typed observation (1000 words) from each of the four types of school settings: Elementary, Middle, High, and Special Setting for a total of 4 reports. If you do not complete the classroom observation hours, you will not pass this course.

Key skills/knowledge for evaluation:

- Can you articulate your assumptions/expectations about a given setting and then identify how your observation affects those assumptions/expectations?
- Can you observe key details, seeing both the “big picture” of the classroom and specific methods, interactions, etc.?
- Can you relate your class work and readings to your observations and provide an insightful analysis?

## 7. Personal Philosophy of Schooling, Learning and Teaching

To summarize learning in this course, to help students clearly articulate emerging beliefs about teaching, learning, schooling & inclusivity, and prepare for future interviews, students will be asked to submit a paper in which you imagine what you would say to the hiring committee of a school district if asked to describe your own distinct set of beliefs about teaching, learning and schooling.

In preparing this assignment, students will develop a paper (4 to 6 pages, double-spaced) over the course of the semester and will experience the process of drafting (the submission of two drafts is required as part of this assignment). More information about the paper will be provided in class and posted on Cougar Courses.

Key skills/knowledge for evaluation:

- Did you draw upon all your resources/experiences (in addition to our class texts) to write your philosophy?
- Are you clear about your own beliefs? Did you address the needs of all learners?
- Can you articulate your ideas fluently and coherently using correct grammar?
- Did you thoughtfully address all areas of teaching, learning, schooling and inclusivity?

## 8. Participation

This class is designed for hands-on, active learning that requires some “stepping out” in order to better understand the role of teacher and learner. Some of these activities include partner and small group teaching presentations, group discussions, and different kinds of reflective writing. The primary purpose of these assignments is personal reflection and growth, and serves as fuel for class discussions. Attending class prepared to discuss assigned readings - and being fully engaged in listening to others and sharing your perspectives - are essential components of this course.

Carefully consider each of the following questions:

- 8) Do you participate in class discussions productively, sharing your knowledge and understandings?
- 9) Do you interact productively with your peers, taking on a variety of roles (leader, follower, etc.)?
- 10) Do you contribute appropriately to group work—do you “do your share”?
- 11) Do you demonstrate you are able to accept others’ opinions and support others’ ideas?
- 12) Do you support your peers during their presentations?
- 13) Do you manage potential diversions (electronics, personal business, appointments, etc.) that can impede your ability to give your full attention to class sessions?
- 14) Do you monitor and adjust your participation to allow for others’ ideas as well as your own to be heard?

## Grading Standards

Grades will be determined by the total number of points earned (100 points possible). A minimum grade of C+ is required in EDUC 350 to qualify as a pre-requisite for admission to the Cal State San Marcos teacher credential program.
